# CHILD DEVELOPMENT ASSOCIATE (CDA)

The Child Development Associate Training Program includes 120 clock hours of early childhood training, which must be completed within 1 year from the enrollment date. In addition, students are required to submit written documentation of completing 480 clock hours working with children in an early childhood child care setting in the last five (5) years prior to the completion of the CDA training program. A minimum of 80 clock hours within the 480 hour requirement must be completed while attending the CDA training program. Students will be formally observed once while working with children in the capacity as a lead teacher. The observation will last three hours and be conducted while the student is enrolled in the CDA training program.

### **Class Schedule:**

CDA is an individualized online program to be completed at the student's convenience, utilizing the guidelines of the program. This program can be accessible to students throughout the year, due to no specific start dates. This course is accessible 24 hours a day/7days a week to fit your schedule. (Any scheduled downtimes will be posted.) The CDA program can be completed as quickly as you desire, but must be completed by the posted dates.

Enrollment Requirements for the CDA Online Program

- Must be 18 years of age or older
- Must possess a High School Diploma, G.E.D., or equivalent
- Proof of current certification in Infant and Child First Aid and CPR
- Must have 40-clock-hour <u>Introductory Child Care Training</u> comprised of Part I and Part II courses
- Must have 5-clock-hour (or .5 Continue Education Units) <u>Early Literacy and Language Development</u>

- Student must be employed at an Early Child Care Center.
- Must be able to speak, read, and write well enough in English to understand and complete the course material.

CANCELLA	TION AND REFUND POLICY	

Should a student's enrollment be terminated or cancelled for any reason, all refunds will be made according to the following refund schedule:

- 1. Cancellation can be by electronic mail, by Certified Mail, or by termination.
- 2. All monies will be refunded if the IECE does not accept the applicant or if the student cancels within three (3) business days after signing the enrollment agreement and making initial payment.
- 3. Cancellation after the third (3rd) Business Day, but before the first class, results in a refund of all monies paid, with the exception of the registration fee (not to exceed \$150.00).
- 4. Cancellation after attendance has begun, but prior to 40% completion of the program, will result in a Pro Rata refund computed on the number of hours completed to the total program hours.
- 5. Cancellation after completing 40% of the program will result in no refund.
- 6. Termination Date: In calculating the refund due to a student, the last date of actual attendance by the student is used in the calculation unless earlier written notice is received.
- 7. Refunds will be made within 30 days of termination of students' enrollment or receipt of Cancellation Notice from student.

## \*IECE Termination/Cancellation Policy

Should IECE need to terminate or cancel a class for any reason, 100% of the program fees are refunded within 30 days of the planned start date. Students will be notified by email, phone, and a certified letter.
